After the scrutinizing the documents including all the affidavits submitted by the school management, the recommendations DEO (S.E.) and DPI (S.E.) Punjab, Chandigarh, the Punjab Govt. has issued the NOC on following conditions,


1. In future regarding any complaint/ Inspection if found that for applying for the NOC you have given the wrong information in the application or if you have not followed the instructions issued by the Punjab Govt. time to time and you are not following the conditions written in the affidavits, in that conditions the NOC will be taken back.
2. The teaching of Punjabi language upto Tenth (Matric) class will be made compulsory in the School and CBSE, New Delhi will made proper arrangements for taking exams of Punjabi and if this condition is not fulfilled the NOC stands cancelled.
3. School management will follow the guidelines of RTE Act, 2009 and also follow the notifications of RTE Act, 2009 issued by the Education Department, Punjab.
4. After getting the affiliation from the CBSE, New Delhi the school management will pay the Salary to all its teaching and non-teaching staff the salary and other allowances equivalent to the employees of the State Govt. through account payee cheque and if this condition is not fulfilled the NOC stands cancelled.
5. You and your management should made satisfy that if any information is required by the District Education Officer or by any senior or by any officer of the education department, the same will be provided by you and required help will also be made. If this condition is not fulfilled the NOC stands cancelled.
6. The safety of the students, Public Health and Sanitation and other conditions required for the issuance of NOC certificate will be inspected by officials of the Punjab Government time to time.
7. The school will follow all the Guidelines issued on 26-11-2018 by the Punjab Government vide Letter No.- 2/93/2009/3EDU-3/1360154.


