- School will not collect any fee forcibly for any proceeding from the parents or guardians. 6.
- School will not denying for admission to anyone:
 - a) Any of child who do not have proof of Birth OR
 - b) If such a child is admitted during the depicted or extended period (for giving admission).
 - Religion, Caste, Place of Birth or on the basis of these reasons.
- 7. School will make sure:
 - a) Any of admitted students cannot be stopped or expelled from any class until his/her elementary education would not be complete.
 - b) Any of students will not be punished physically or mentally.
 - c) Any of students will not require passing any board education before completing elementary education.
 - d) As per Rule 21, Certificate will be given to every student after getting elementary education.
 - e) Handicapped, disabled or special needs students will be admitted under the law.
 - f) As per section 23 sub-section (1), appointed Teacher fulfills of his/her education qualification. If already appointed, who will complete their required at-least education qualification from the date of enactment of law during the period of five years while
